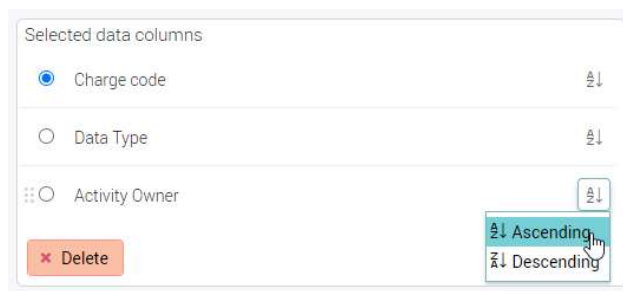
'Period profit' report column heading changes (3521, 3727, 5458)

The column heading changes to exported CSV files are:

- 'Recommend' has been changed to 'Rec. Charge'.
- 'Total Time' to 'Total Time Cost'.
- 'Total Materials' to 'Total Materials Cost'.
- 'Total Purchases' to 'Total Purchases Cost'.
- 'Profit' to 'Net profit'.

Data viewer - Option to sort 'Selected data columns' (5886)

Ascending and descending options have been added to each selected data column.



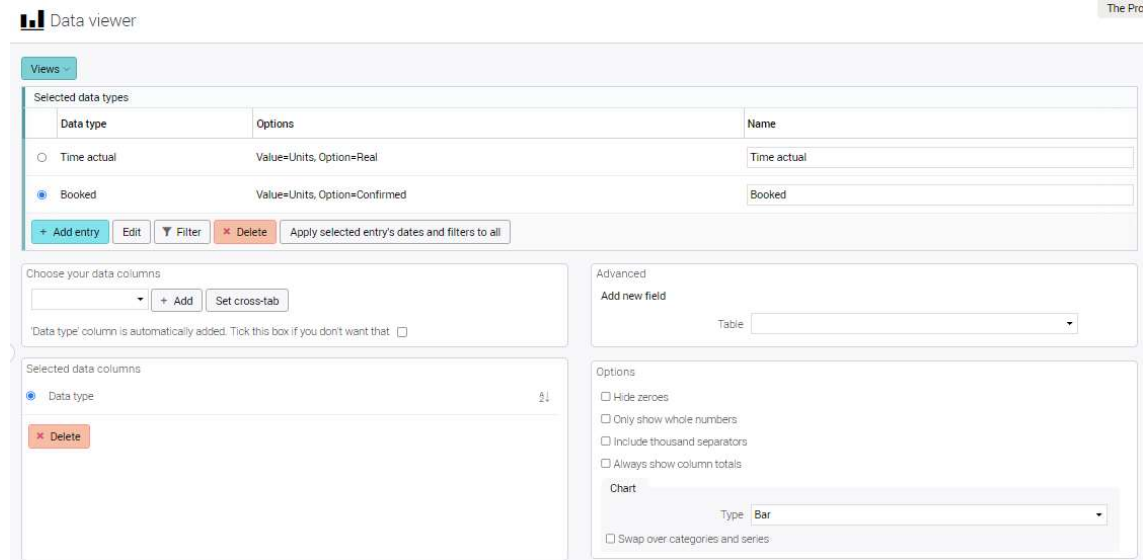
Data viewer - Allowing overlapping date ranges (5833)

When overlapping date ranges occur, a system message appears allowing users to continue should they wish to.

Data viewer – Advancements to the ‘Options’ panel (6485) (6362)

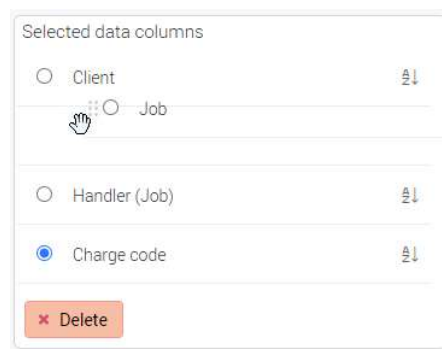
The ‘Options’ panel has moved to the right-hand side of the page and additional options include:

- Only show whole numbers.
- Include thousand separators.
- Swap over categories and series.
 - If unticked, the ‘y’ axis on the chart displays the data type categories.
 - If ticked, the ‘y’ axis on the chart displays the dates.



Data viewer – Drag and drop on the ‘Selected data columns’ panel (5422)

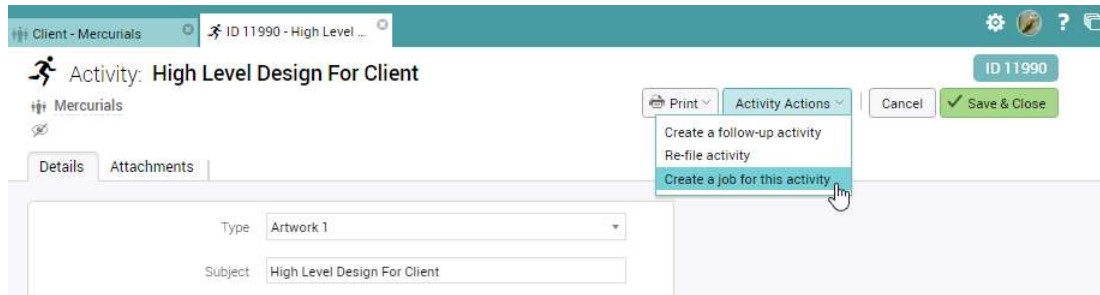
Selected data columns can be moved to any position on the list using drag and drop.

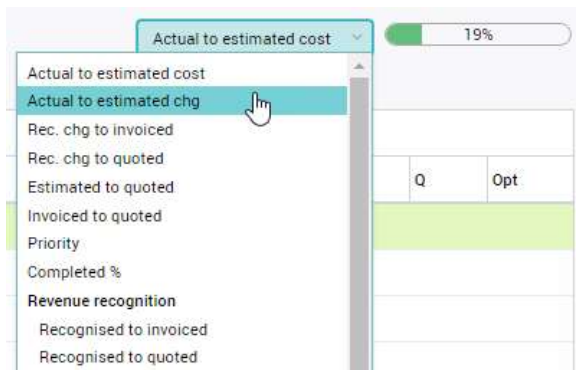
Creating a job from an activity (3403)

A job can be created from inside an activity record via the 'Actions' drop-down menu and then selecting 'Create a job for this activity'. This feature is only available if the activity is at client level and not linked to a job.



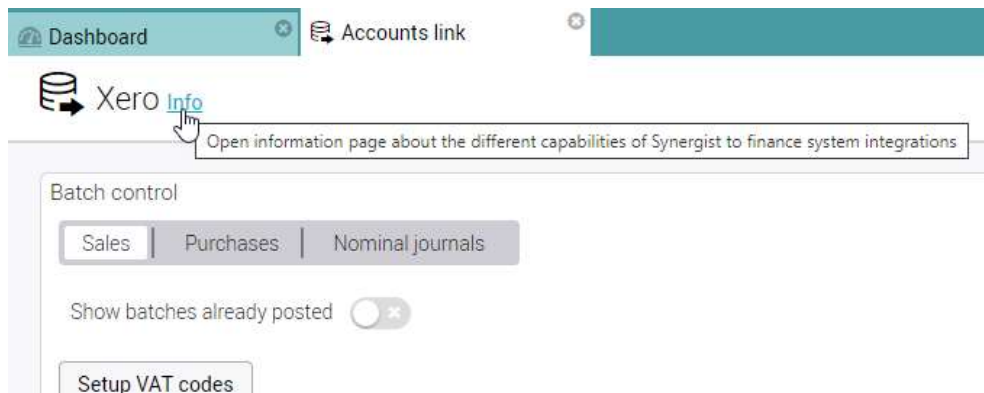
Selecting the thermometer type on job and phase estimates (4224)

The thermometer on the job or phase estimate page now has a menu allowing users to choose the type of calculation.



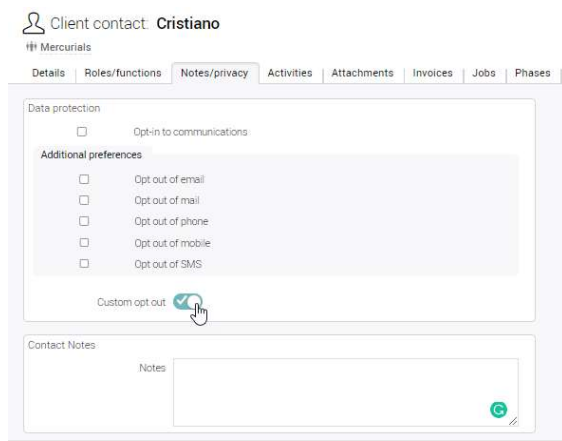
Integration with Microsoft Dynamics 365 Business Central (4880)

A new integration has been added for Microsoft Dynamics 365 Business Central. Due to limitations in the Dynamics 365 Business Central API, there are some caveats, these are documented in the new "Info" page available on the Synergist accounts link screen as shown below.



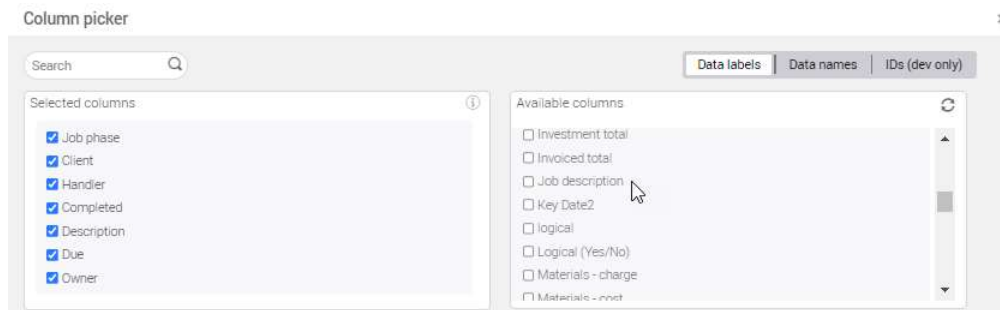
‘Custom opt out’ on client contact (4782)

‘Custom opt out’ has been added to the ‘Notes/privacy’ tab on client contacts - giving more options as to which communications client contacts can be opted out of.



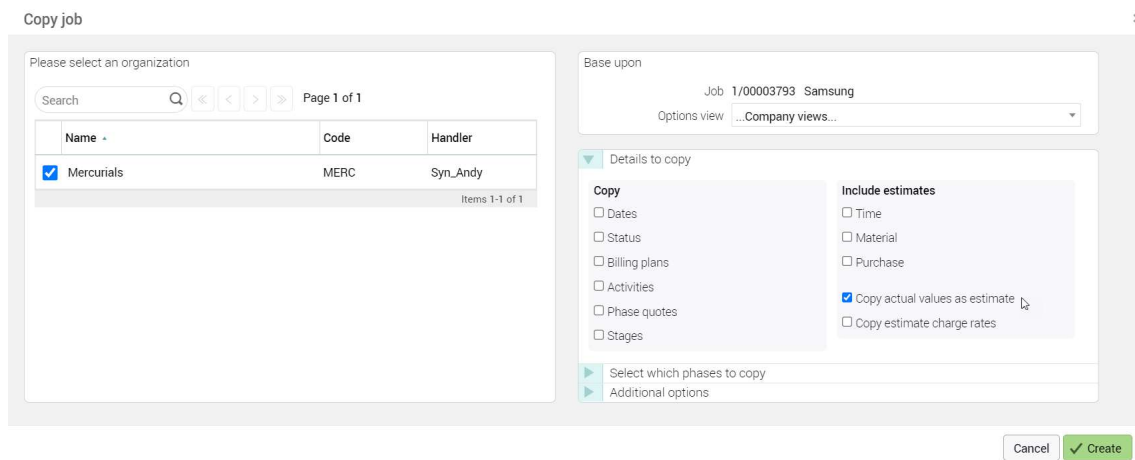
‘Job description’ added to the phase list column picker (5245)

‘Job description’ can now be selected as a column on the ‘Phase list’.



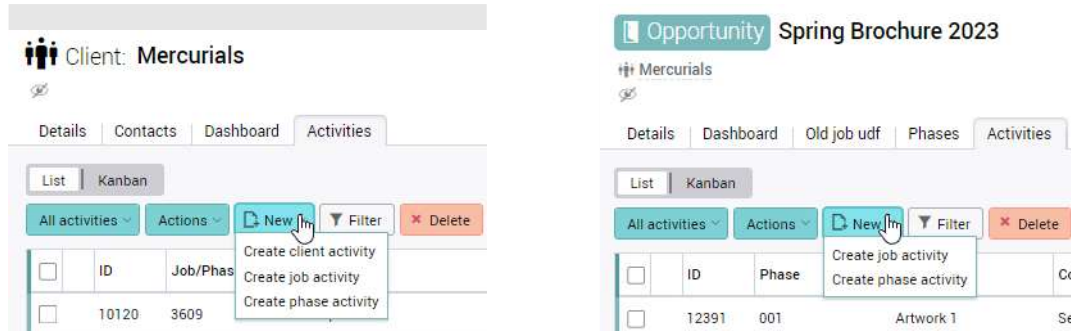
‘Use actual values’ renamed to ‘Copy actual values as estimate’ (5435)

For added clarity when copying a job, ‘Use actual values’ has been renamed ‘Copy actual values as estimate’.



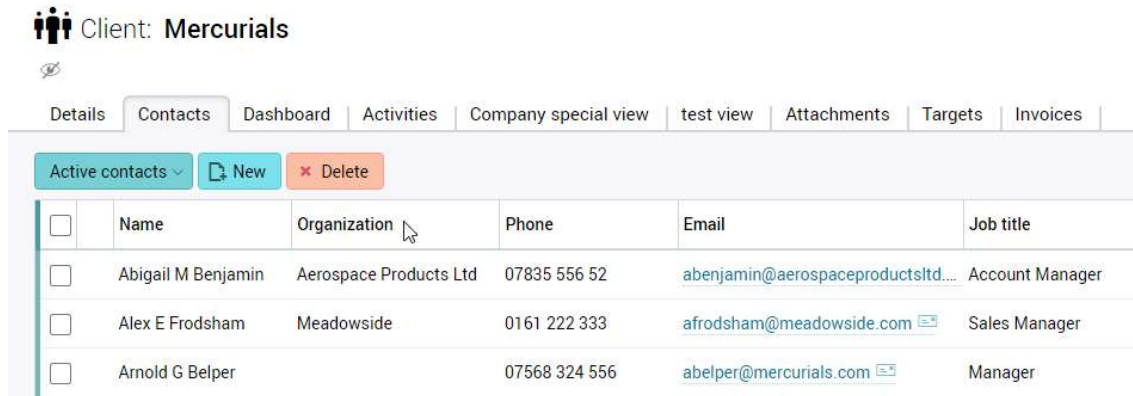
Drop-down menu added to 'New' button on Client and Job activity records (6283)

When creating a new activity from a client record or job record, a dropdown menu has been added to the 'New' button with options to create an activity at client, job or phase levels.



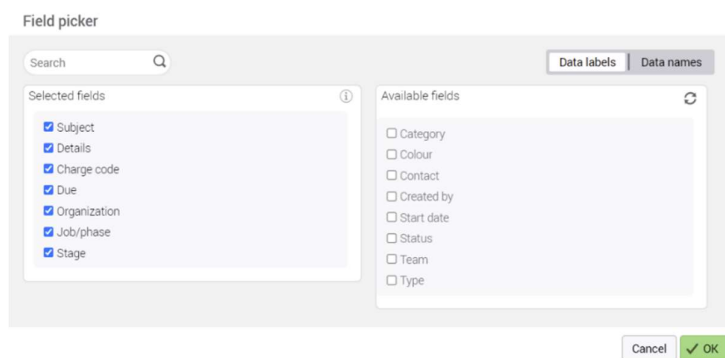
'Organization' column added to Client contacts (5664)

The new 'Organization' column appears if the client has linked organisations - making it easier to see which organization the contacts belong to.



Ability to choose details displayed on Kanban cards (3408)

This feature enables users to customise their Kanban cards by adding, removing and re-ordering Kanban card fields. The 'Field picker' is available on the main activities list Kanban board, by clicking on the 'Options' button. Please note that the Kanban field choice can be saved with the view in the same way as with lists.



Job level sales invoice revenue allocations (3418)

This option enables users to see a single billing / revenue allocation per job on the invoice, and to be able to update the totals without expanding to see phase allocations.

When turned on, the invoice allocations tab has a modification to its current functionality. Instead of only showing the phase allocations (current functionality), it has a summary row that represents the whole job. On a multi job invoice there are multiple summary rows – one for each job.

If the company setting is set to default to 'Collapsed - show job level allocations' it defaults to showing only the summary row(s). If the setting is set to 'Expanded - show phase level allocations' it defaults to showing the job summary row, and all the phases for that job below the summary row.

Users can still edit the fields on the phase allocation lines on a draft invoice to decide how much is billed and recognised. However, in certain situations it is also possible to edit the allocations at job level - when the job level allocation has not been expanded to show phases.

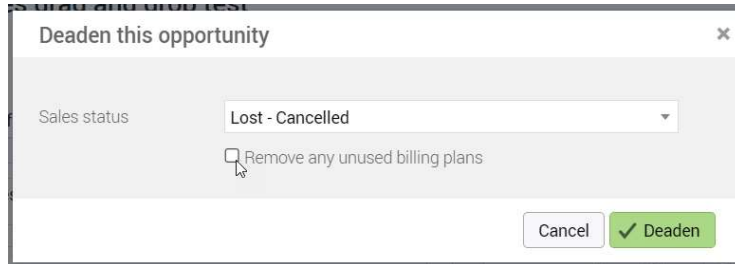

Option to delete all deleteable billing plans when deadening an opportunity (4809)

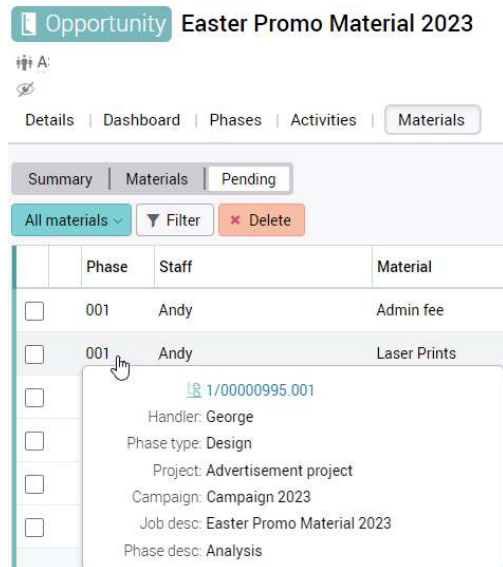
On deadening an opportunity, a new option in the dialog appears labelled 'Remove any unused billing plans' (shown below). This is ticked by default. When ticked this will look for any billing plans associated with this job (can be on jobs or phases) and will delete these if the user has the privileges for each of them to do so. If any of these fail to be deleted a message will appear stating how many.



'Phase' column added to 'Materials' and 'Purch & exp' tabs (6067)

A phase column and tooltips have been added to the 'Materials' and 'Purch & exp' tabs on job records. Click on the column header to sort the phases into ascending/descending order. Hover the cursor over a row to view the tooltips.

Note: Tooltips have also been added to the 'Time' phase column on job records.



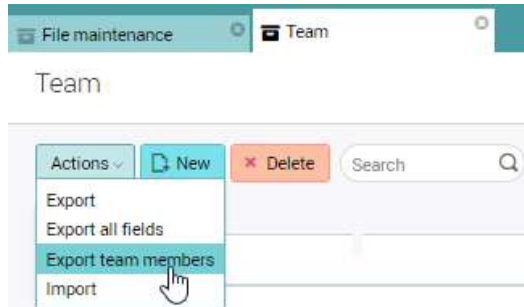
Accounts integration with Implicit (4444)

A new integration has been added for Implicit. Due to limitations Implicit API does not currently accept tax amounts, Implicit will recalculate them. Transactions must be cross-checked in Implicit prior to final posting within Implicit. This limitation is under consideration by Implicit to allow tax amounts to be specified which could create a tax adjustment.

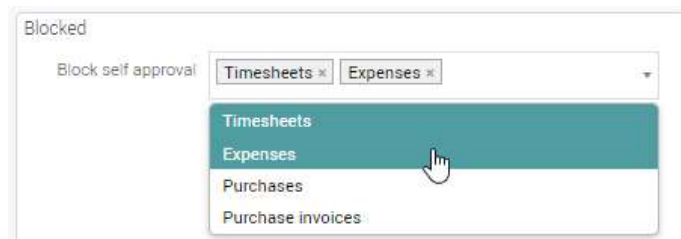
Team list export for team members (8867)

An 'Export team members' option has been added to the Actions button on the Team list.



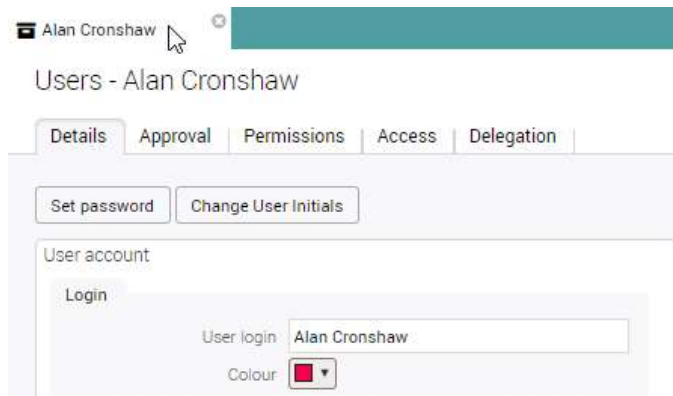
Block self-approval of Timesheets, Expenses, Purchases and Purchase invoices (3037)

A new feature to control the self-approval of 'Timesheets', 'Expenses', 'Purchases' and 'Purchase invoices' is located on the User record 'Approval' tab.



User's full name displayed on 'User record' tab (9764)

The user's full name is displayed on the user record tab - making it easier to identify the record owner.



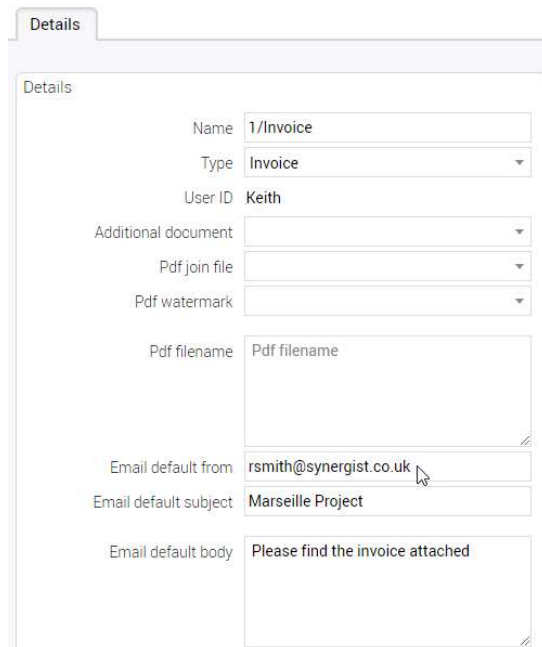
‘Email default from’ in Office 365 (3553)

This new feature makes it possible to assign a different ‘From’ address when emailing reports through Office 365. It is particularly useful for sending out emails from a generic address such as ‘Accounts’ or ‘Sales’, instead of it being from a sender’s email address.

To activate, open a report relating to ‘Invoicing’, ‘Purchase orders’ or ‘Quotes’ and complete the ‘Email default from’ field with a valid email address. For multiple reports, open each report and amend the ‘Email default from’ field.

Please note that ‘Outlook’ permissions are checked on sending to ensure the user has permission to use the email address.

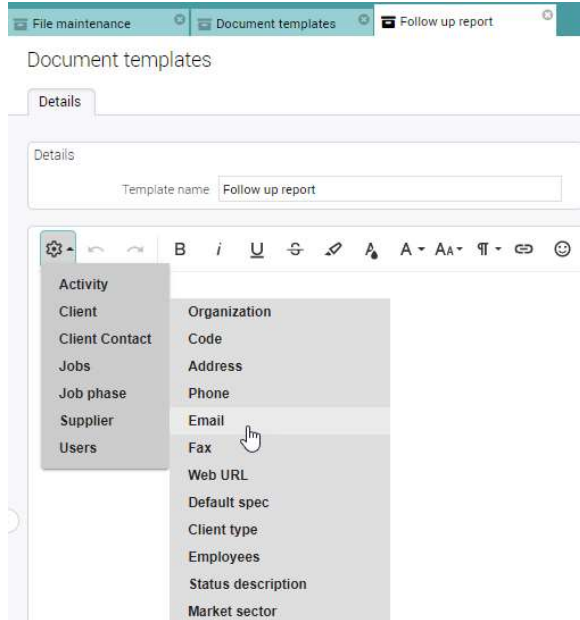

Only parent custom field lookup items with no associated data can be amended or deleted. Parent custom field lookup items with data associated to them cannot be amended or deleted but can be marked as inactive.

Short code for client email added to document templates (3929)

A short code for client email has been added to Document templates.



'Investment' column added to 'Purchase orders' report (3974)

Running a CSV on a Purchase orders report, the table includes a new 'Investment' column which displays 'Y' or 'N' depending on whether purchases are marked or not marked as investment.

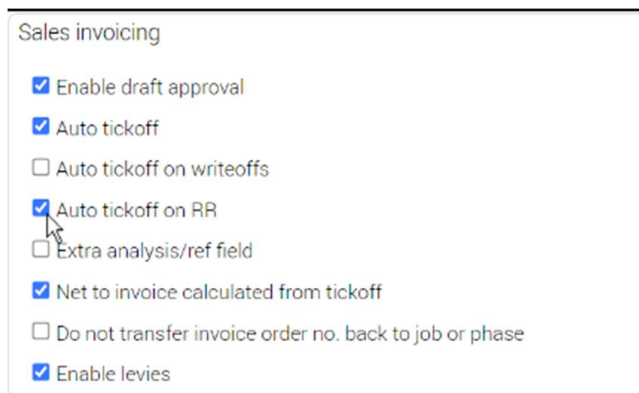
Reset password requirements displayed (4398)

When a user logs in and is required to change their password, a list of password requirements is displayed. On clicking 'Reset', any unmet password requirements are listed.



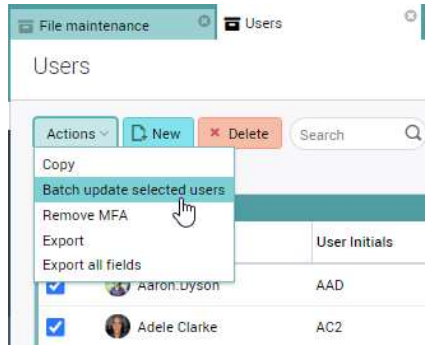
Auto tickoff for revenue recognition added in company settings (4446)

An 'Auto tickoff for RR' option has been added to the billing section on the Switches tab in Company settings. When using auto billings plans, raising an RR invoice against it the costs can now be set to automatically ticked on or off.



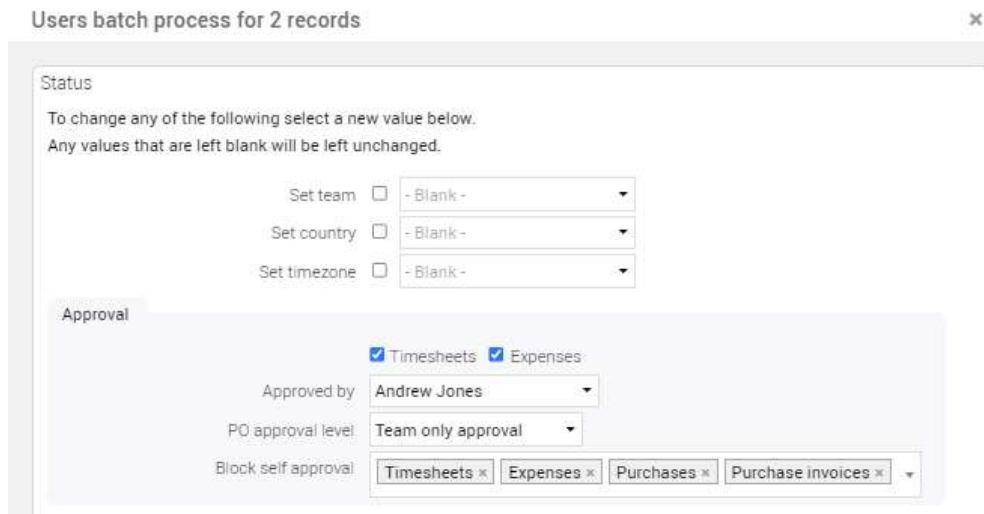
'Approval' section on batch updating the users list – (4631) (6188)

When batch updating the File maintenance Users list, a new 'Approval' section has been added.



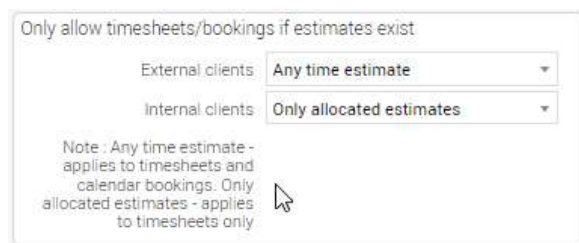
Existing checkboxes - 'Timesheets', 'Expenses' and 'Approved by' - are framed to make it clearer how they are linked.

New checkboxes - 'PO approval level' and 'Block self-approval' – have been added for increased functionality.



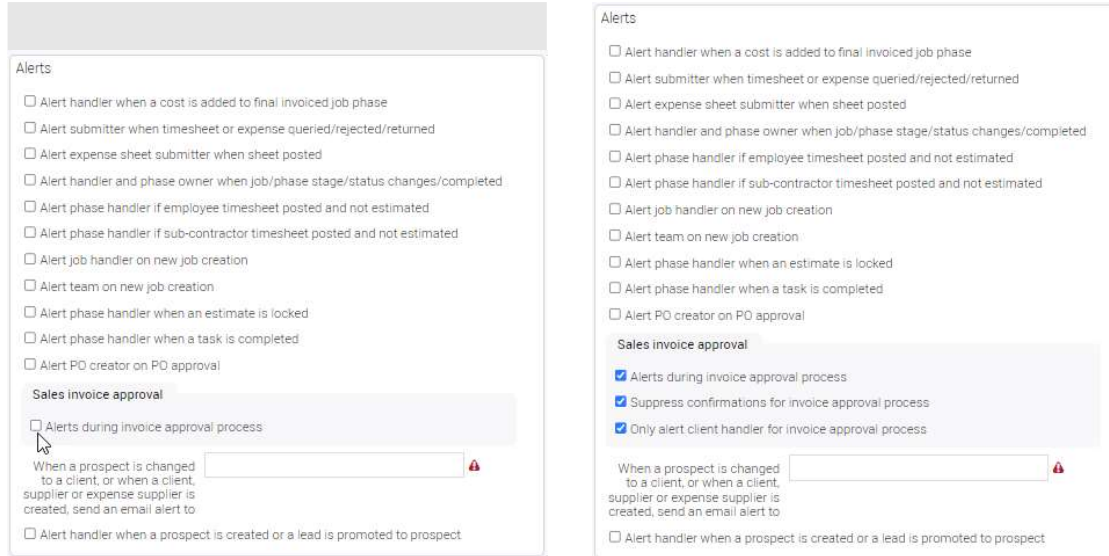
Note added to 'Only allow timesheets/bookings if estimates exist' (4733)

'Sales invoice approval' section on Company Alerts (6490)

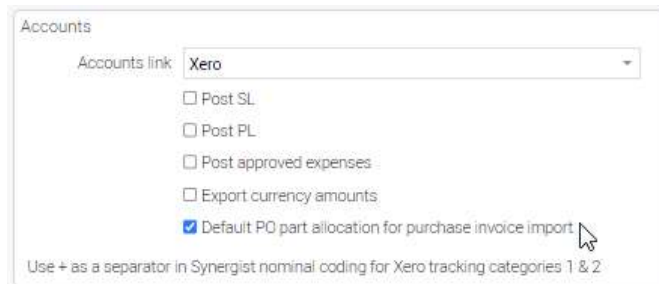
The existing checkboxes - which control email alerts during the sales invoice approval process - have been framed to make it clearer how they are linked.



Invoice final checkbox default option when importing from Xero (5138)

'Default PO part allocation for purchase invoice import' has been added to the 'Accounts panel' for the following Account links:

- Quickbooks Online

Calendar Bookings

Auto colouring bookings on Projects and Campaigns (3562)

Colours can be assigned to projects and campaigns via the colour picker on project or campaign records. The assigned colours are then displayed in the 'Colour' column on Project / Campaign lists.

When a calendar booking is associated with a project or campaign, the booking colour matches the colour assigned to the project / campaign. Booking colours can be added in other places too, and the hierarchy of which colour is shown is listed below:

- Booking colour
- Campaign
- Project
- Client
- Current stage
- Job/Phase handler
- Staff/User

Recurring bookings functionality upgrade (3662)

When creating a recurring booking, if the start date of the first recurring booking is the same as the source booking, the first booking in the sequence is the source booking and it is linked to the newly created bookings.

Example:

- A source booking has a start date of Monday March 13th.
- Right click on the source booking to create a recurring booking.
 - Leave the start date unchanged - Monday March 13th.
 - Set the number of recurring bookings to 5 with a frequency of 'Every day'.
- The sequence of bookings totals 5 - running from Monday to Friday.

If the start date of the first recurring booking is before the source booking, a new booking will be created for the start date and every recurrence after that, including the source booking.

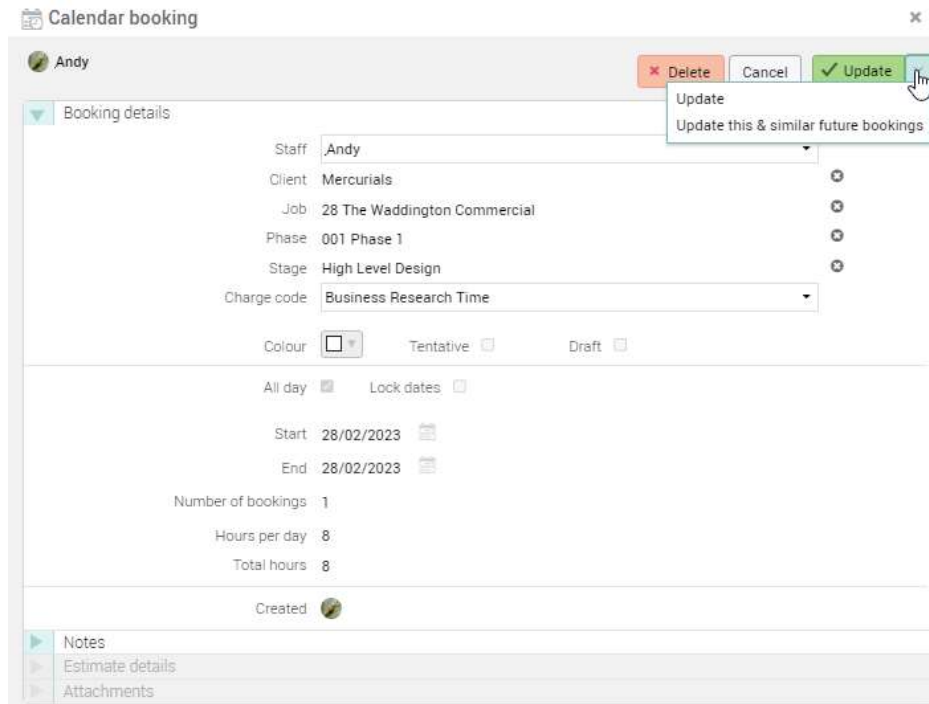
Example:

- A source booking has a start date of Monday March 13th.
- Right click on the source booking to create a recurring booking.
 - Change the start date - Friday March 10th.
 - Set the number of recurring bookings to 5 with a frequency of 'Every day'.
- The sequence of bookings will total 6, running from Friday to Thursday.

Advancements to 'Change job/phase/stage' modal window (3665)

Advancements to the 'Change job/phase/stage' modal window include:

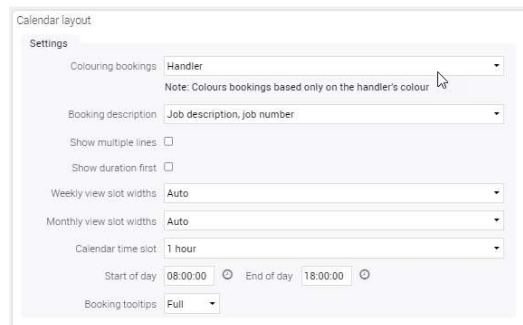
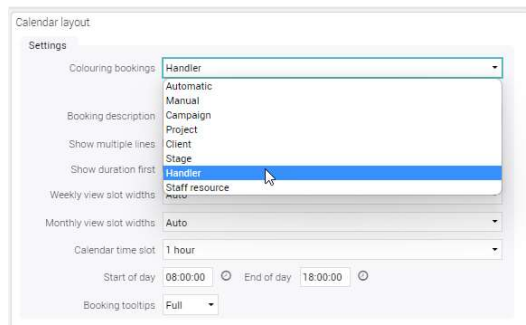
- 'Save' button renamed 'Update'.
- Options on the 'Update' button:
 - Update
 - Update this & similar future bookings
- Staff resource, client, job, phase, stage and charge code fields can be updated.



Please note that non-working days are accounted for when changing resources.

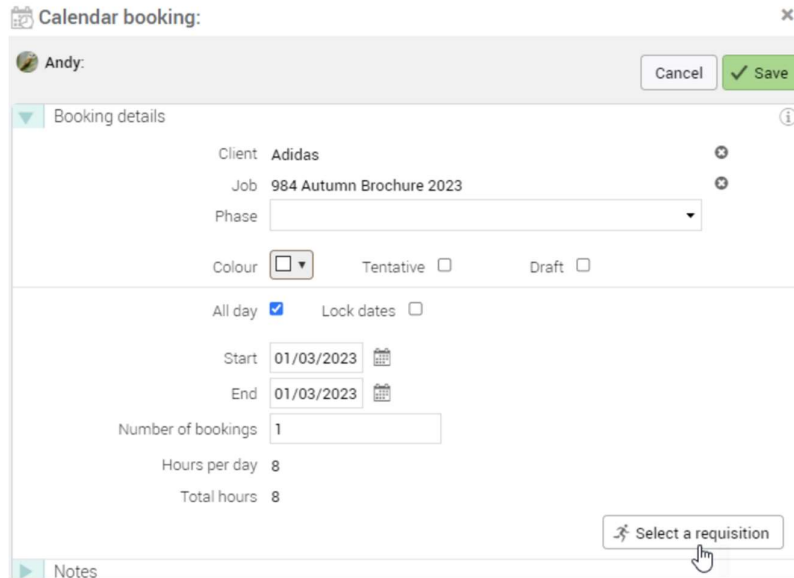
Colouring bookings (5733)

'Colouring bookings' has been added to Preferences in Calendar bookings and My calendar enabling the user to control the way colours are used. Upon selection, a note appears below the field with an explanation.

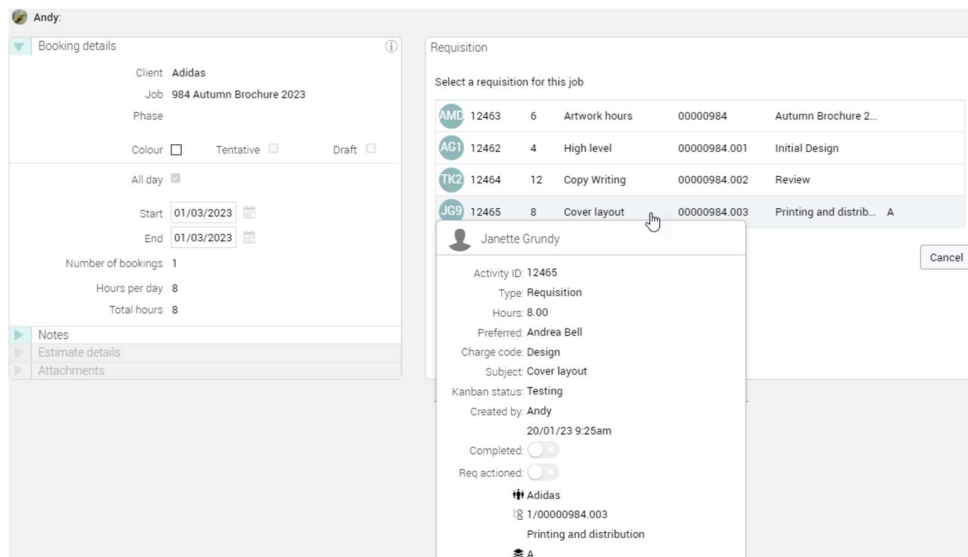


‘Select a requisition’ option added to bookings

Using the new 'Select a requisition' button, this feature enables users to draw a booking on the calendar and then link it to an available requisition without the need to drag and drop from the calendar bookings requisitions list.



On clicking the ‘Select a requisitions’ button, the right-hand side panel displays a list of available requisitions. Note: If there are no available requisitions, the right hand panel does not appear and a screen prompt appears.



On selecting a requisition from the list, the details appear in the right-hand panel. Click the ‘Unlink’ button to unlink a linked requisition from the booking.

Caution message added in calendar preferences (4972)

Under the ‘Loading’ header in ‘Calendar preferences’ messages have been added below the tick box options ‘Show available hours in loading view’ and ‘Show available hours when there are no bookings (can slow down the calendar refresh)’. As shown below the messages caution about what is being included in the option for

performance reasons.

Search included for requisition numbers in calendar (3725)

The search bar now identifies requisition bookings by highlighting the staff resources containing the same requisition number.

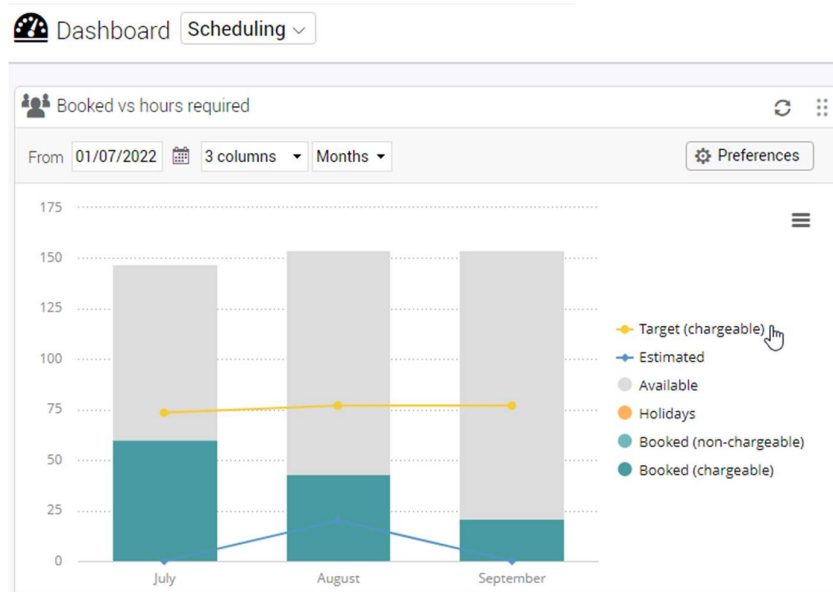

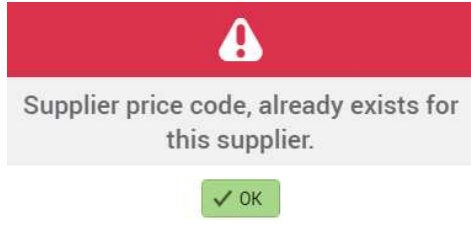

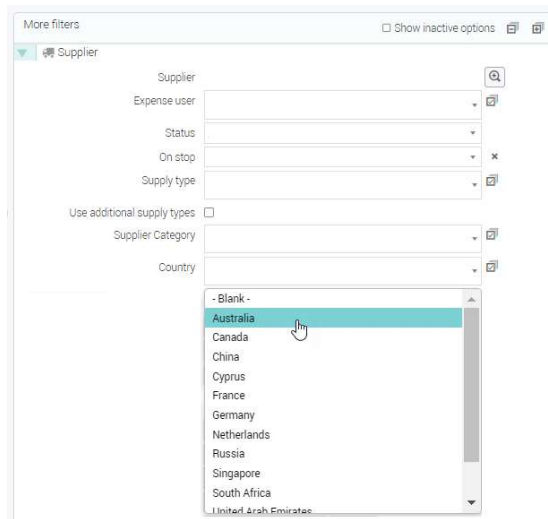

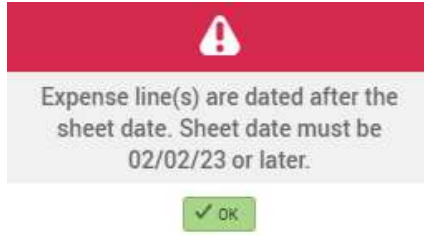

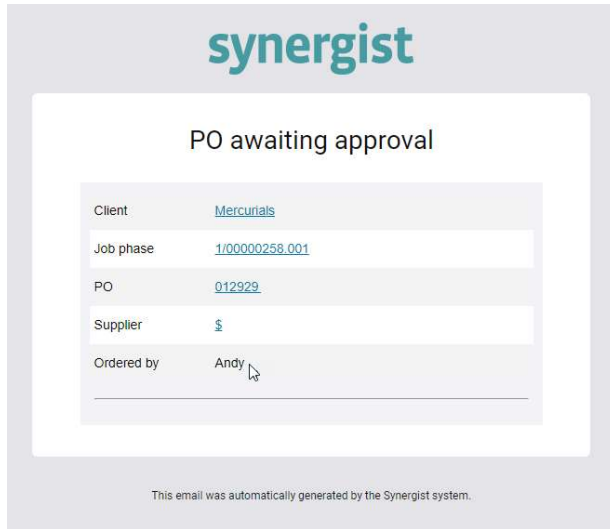

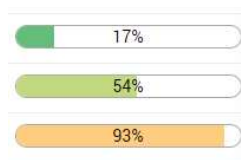

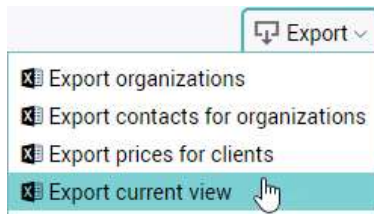

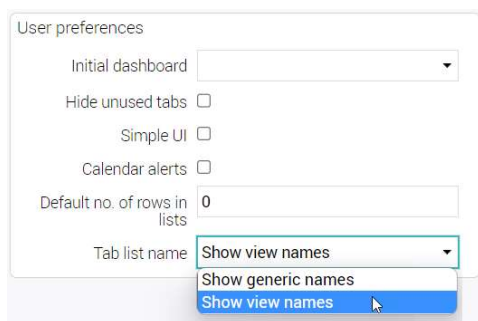
